

#### Introduction

Equilibrio-Balance project, led by the Women's Institute (WI), will be developed in collaboration with the Spanish Federation of Municipalities and Provinces (SFMP) and the Norwegian Association of Local and Regional Authorities (KS), under the framework of the Programme "Equality and Conciliation", funded by the European Economic Area Financial Mechanism.

Equilibrio-Balance Project is a commitment to fostering shared responsibility (co-responsibility) in domestic work and care.
